Contract Title: Procurement of laboratory equipment (water and wastewater)

1. This Invitation for Bids follows the General Procurement Notice (GPN) for this Project that appeared in UN Development Business issue of August 5, 2014.

2. Ukraine has received financing from the World Bank toward the cost of the Second Urban Infrastructure Project (UIP2), and intends to apply part of the proceeds toward payments under the contract KRD-IFB-04 "Procurement of laboratory equipment (water and wastewater)".

3. Regional Utility Production Company "Dnipro-Kirovograd" now invites sealed bids from eligible bidders for procurement of the following goods: one (1) Inductively coupled plasma optical emission spectrometer (ICP-OES spectrometer) set, three (3) sets of Spectrophotometric system for sample analyses in visual range. Single beam spectrophotometer, one (1) set of Gas Chromatograph, On-site assembly, installation and start-up of supplied goods and training of personnel, including provision of operation and maintenance manuals. This goods must be delivered during 90 (ninety) days following the date of signing of the Contract.

4. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, dated January 2011 as revised through July 2014 Corrigenda ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

5. Interested eligible bidders may obtain further information from Regional Utility Production Company "Dnipro-Kirovograd", Roman Kravchenko, e-mail: invest@dnipro-kirovograd.com.ua and inspect the bidding documents during office hours from 08:00 a.m. to 05:00 p.m. local time at the address given below (1).

6. Qualifications requirements include:

If Bidder is Manufacturer:

- (i) Local Bidders should submit documentary evidence of not having deferred debts to Tax authorities.
- (ii) a) The Bidder shall have at least five (5) years of experience in manufacture of similar goods. Appropriate documents will be submitted to confirm this requirement.
- b) The Bidder shall have at least two (2) successfully completed contracts for supply of similar goods during the last three (3) years each in amount not less than US\$ 200 000 (two hundred thousand US dollars).

If Bidder is not Manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section IV, Bidding Forms):

- (iii) the Manufacturer shall demonstrate the above qualifications (i), (ii) a), and the Bidder shall demonstrate that it has successfully completed at least two (2) contracts for supply of similar goods during the last three (3) years each in amount not less than US\$ 200 000 (two hundred thousand US dollars).
- (iv) Local Bidders should submit also documentary evidence of not having deferred debts to Tax authorities.

The winning Bidder shall submit evidence that it is/will be represented by a certified agent in Kirovohrad or any other closest (within 350km) location, equipped and able to carry out Supplier's servicing, repair and spare part stocking obligations required under this bidding document. Such evidence in written form (e.g. signed Service Agreement with existing certified service center, credible evidence of establishment of certified service facility, etc) shall be provided by the winning bidder prior to signing of the Contract.

A margin of preference for certain goods manufactured domestically shall not be applied. Additional details are provided in the Bidding Documents.

7. A complete set of bidding documents in English language may be purchased by interested eligible bidders upon the submission of a written application to the address (1) below and upon payment of a nonrefundable fee of UAH 3 300 (three thousand three hundred Ukrainian Hryvnia) or USD \$150 (one hundred fifty US dollars). The method of payment will be banking transfer to the account indicated below. The document will be sent by airmail for overseas delivery and surface mail or courier for local inland delivery or can be picked from the address (1) below.

8. Bids must be delivered to the address (2) below on or before 12:00 noon local time November 24, 2015. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address (2) below on 12:00 noon local time November 24, 2015.

9. All bids must be accompanied by a Bid Security of not less than two percent (2%) of the bid price.
